**Subject: Reminder for correction of LOC data 2025-26, reg.**

**Madam/Sir,**

This is in continuation to CBSE LOC notification dated 27.08.2025 and subsequent reminders issued multiple times thereafter, whereby all the principals were directed to submit the accurate data in List of Candidates (LOC) for Class X and XII, 2025-26.

Vide notice dated 18 September 2025, all the concerned were informed that after the LOC has been submitted, a data verification slip will be issued to the candidates / parents. If there is any correction in candidate's particulars: name, parent name, DOB or subject correction, the same can be done during the schedule for correction of LOC data. The opportunity for correction of LOC data will be provided to the schools as per the following schedule :-

It was also informed that in classes X and XII, no correction will be made thereafter.

To avoid any problem, the following requests are once again to be made to the parents:-

1. Check whether the personal data of your ward i.e. name, date of birth, mother name and father name has been correctly filled in the LOC.
2. All names with the expanded form has been filled in and not the short names as in future at many places, documents in extended form are required.
3. The surname has been given in case your ward is planning to go abroad as this is the requirement of several countries.

6. Subjects have been filled in with due care in the LOC of both classes X and XII as no change will be accepted after schedule for correction for the same.

By launching the correction window as per the above schedule, CBSE is once again providing the schools / parents / students another opportunity to ensure that only the correct data of the students is filled in the LOC. This will also help in the smooth conduct of the examinations.

No other opportunity for change / correction of data will be provided thereafter.

In view of above, all the schools are requested to bring the contents of this circular to the notice of all the concerned students & parents and submit correction in data (if any) in the LOC strictly as per schedule given above.
